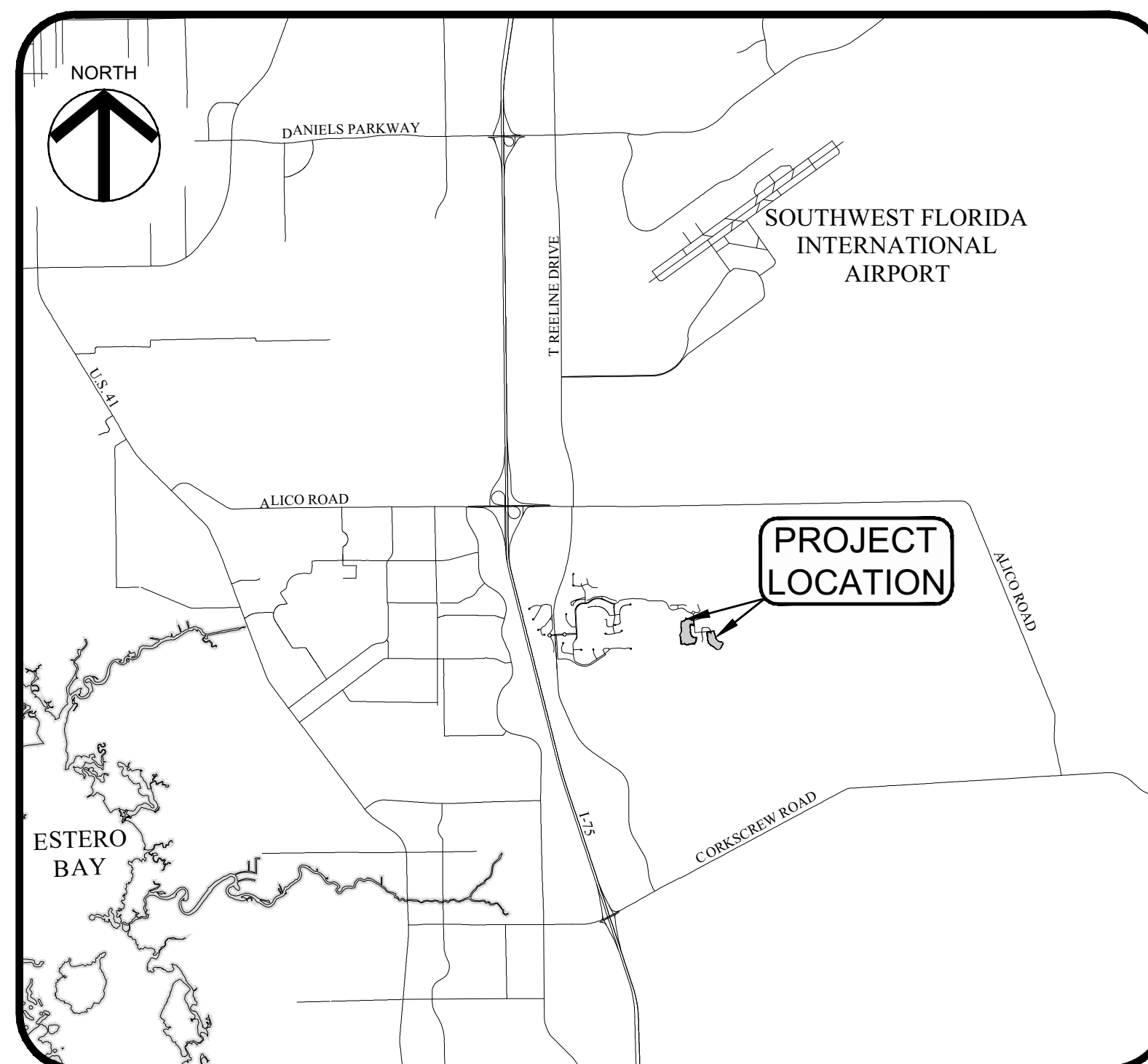

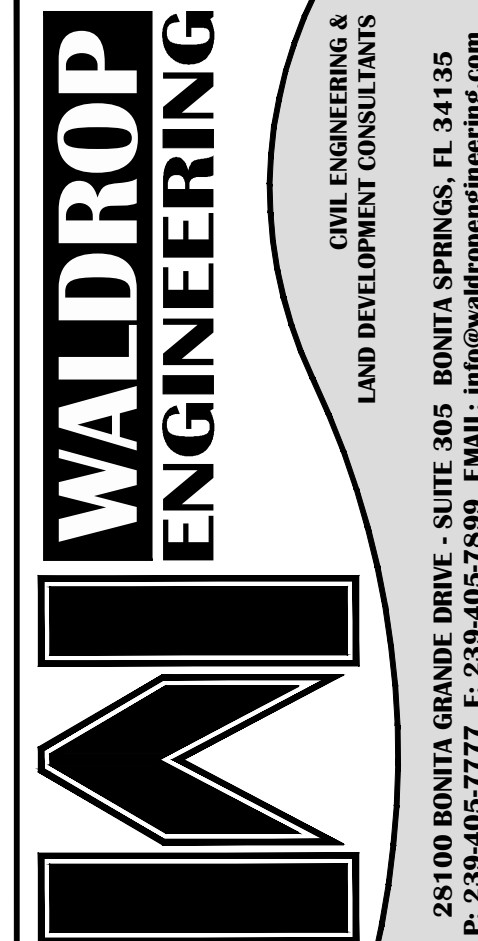


PROJECT LOCATION MAP

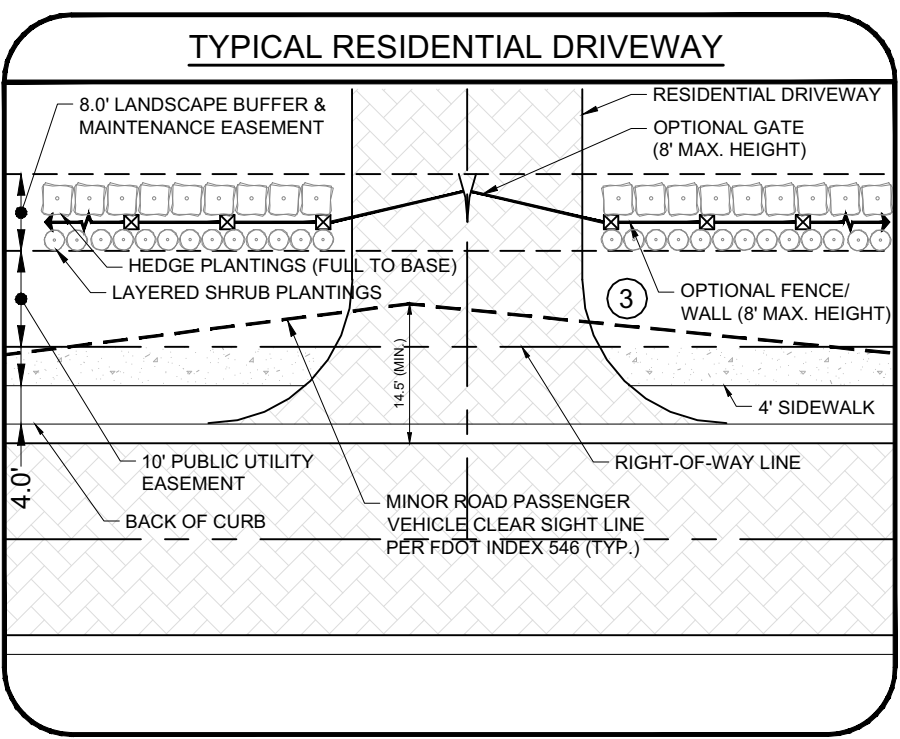
