Public notice advertised Community Information session within the Caloosahatchee Shored Planning Community, was given by a "Legal Notice" in the News Press on 4/19/2019 which is a general circulation daily and which covers the Caloosahatchee Shored Planning Community.

There were 29 Residents of Cypress Woods and 3 Board of Directors (Judy Lawrence VP, Randy Payne Director & Emily Ross Campos Director). There were no non-residents attending. Attached are the sign in logs for each category.

The meeting was called to order at 6:01 PM by Vice President of the Board of Directors, Judy Lawrence. Judy provided a general overview of the purpose of the meeting and the project. Judy then asked for any questions from the audience. There were 3 individuals who asked questions; 1) what is the time frame for disposition of this application from the county; 2) clarification of why we are asking for an "unenclosed accessory structure" rather than just a gazebo; 3) what would be the next step once we finds out the results of this application.

Cypress Woods RV Resort Homeowners Association, Inc. Board of Directors will pursue the answers to these questions by:

- A) Asking the Land Development Office what is the normal processing time for results of an application;
- B) Provided an explanation of why we are asking for an "unenclosed accessory structure" rather than just a gazebo to give each owner the flexibility to stick build an unenclosed structure rather than trying to retro-fit an existing metal or wood gazebo that might not meet county codes or permitting.

- C) Pursue the question with the appropriate Lee County officials to find out what the next process will be if we are approved to allow "unenclosed accessory structure" on our lots.

The meeting was adjourned at 6:20 PM.
